

## Mini-grants program yields large impact.



Fairfax County, VA – The Center for Cultural Exchange, based out of Providence district, is the latest arts organization to have received a \$1,000 *Fast Track Grant* by the Arts Council of Fairfax County. The grant enabled the organization to pay for uniforms and to receive training in the arts of Wu-Style Tai Chi and Tai Chi Ball taught by instructor Tian Meng Yi, a visiting graduate student from Beijing Sports University in China. As a result their nine member strong youth group will perform a Tai Chi fan dance at the Kennedy Center on February 9<sup>th</sup>, 2015.

The *Center for Cultural Exchange* is a Chinese cultural arts organization promoting intergenerational activities and cultural performances utilizing the practice and art of Wu Shu, Tai Chi, and Qigong. Ms. Pei explains: “Wu Shu, in Chinese, means “martial arts”, and Qigong translates as “life energy cultivation.” As a result, Qigong is an important internal aspect of Tai

Chi, and Tai Chi is a sub-branch of Wu Shu. Our vision is to enhance people’s understanding of this cultural art form.”

The *Fast Track Grants* program was initiated in 2014 by the Arts Council to allow smaller arts organizations to quickly execute programs and services, and fund unforeseen needs. Since its inception the Arts Council has awarded five grants. Organizations with an operating budget of less than \$400,000 are eligible to apply for up to \$1,000.
