Aligned with the IACC's mission of fostering the Iranian American community through organized educational and cultural activities, our 2018 Persian traditional and folkloric concert will be performed by Pars Place's Music Institute on April 29th, 6:30pm at The Ritz-Carlton, Tysons Corner. Our current application for Fast Track grant is based on an unexpected cost added to our budget for the April 29, 2018 Concert. One of planned performers, Mr. Analoui – percussionist- who lives in Washington DC., resigned due to his mother's health problem. We recently hired Behnam Daneshvar, an equally qualified performer, who lives in Seattle and has to travel and reside in Vienna VA temporarily to perform at the April 29th concert.

For this replacement, we will have the following unexpected costs: airline ticket; hotel stay from April 26th to April 30th, accommodations, and transportation.
